Applications are invited from eligible candidates for the recruitment to the vacant posts of Lower Division Clerk (Post Code 1), Technician (Post Code 2) and Technical Assistant (Post Code 3 to 5) at ICAR-Central Inland Fisheries Research Institute, Barrackpore and its Regional Centres/Stations as per details given below. **2.** Reservation:- Reservation for SC/ST/OBC/Ex-Servicemen/PWD, etc. categories is available as per extant Government Orders. NON-CREAMY LAYER CERTIFICATE MUST BE PRODUCED BY THE OBC CANDIDATES IN THE EVENT OF SELECTION. The copy of relevant certificates as given in Annexure I to VI, duly self-attested by the applicant to be enclosed with the application.

- 3. Nationality/citizenship:- A Candidate must be either:
- A. A citizen of India, or
- B. A subject of Nepal, or
- C. A subject of Bhutan, or
- D. A Tibetan refugee who came over to India before the 1<sup>st</sup> January, 1962 with the intention of permanently settling in India, or
- E. A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African Countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.

Provided that a candidate belonging to B, C, D and E above shall be a person in whose favour a certificate of eligibility has been issued by the Government of India.

A Candidate, in whose case a certificate of eligibility is necessary may be admitted to the Examination but the offer of appointment will be given only after the necessary eligibility certificate has been issued to him/her by the Government of India.

## 5. AGE RELAXATION:

- A. For the post of LDC, the maximum age limit for Council's employees will be relaxable up to 45 years.
- B. There will be no age limit for the post of Technician and Technical Assistant for ICAR employees.
- C. All the RAs/ SRFs who have been engaged on contractual basis in different Institutes as on date will be considered for all regular vacancies to be filled up by direct recruitment in the grades of Technical Assistant in accordance with their qualifications by granting them appropriate relaxation in the upper age limit to the extent of their spell they were actually engaged as RAs / SRFs in different projects subject to a maximum of 16 years 3 months. However a break of more than 6 months will not be accepted and will be treated as an inordinate spell of break. If during the spells of break the RA is engaged in a similar ICAR project then this would be acceptable considering the fact that this employment is under the umbrella of ICAR. The relaxation is governed by ICAR Circular No. 19(25)/2011-Estt.IV, dated 24<sup>th</sup> January, 2012.
- D. The candidates should note that the Date of Birth as recorded in the Matriculation/Secondary Examination Certificate or an equivalent certificate only will be accepted by the Institute for determining the age and no subsequent request for its change shall be considered or granted.
- E. Candidates are advised to opt only for such posts for which they have the qualification and are within the prescribed age limits. Permissible relaxation of upper Age Limit prescribed above and Category Codes for claiming age relaxation as on date of reckoning as follows:-

F) Ex-servicemen who have already secured employment in Civil side under Central Government on regular basis after availing of the benefits of reservation given to ex-servicemen for their re-employment are not eligible for Fee concession. The period of "Call up Service" of an Ex-serviceman in the Armed Forces shall also be treated as service rendered in the Armed Forces for purpose of Age Relaxation as per rules.
