ICAR-Central Inland Fisheries Research Institute (CIFRI) is a premier fisheries research institute in India established in 1947 and functioning as a unit of Indian Council of Agricultural Research (ICAR), New Delhi, under the administrative control of Department of Agricultural Research and Education, Ministry of Agriculture and Farmer's Welfare, Government of India. The headquarters of the Institute is located at Barrackpore, Kolkata 700 120.
- 2. The Institute has developed a technology (FRP coracle with seating arrangement). Hence, Expression of Interest (Single Bid) is invited from reputed manufacturers for empanelment as manufacturer and suppliers of FRP CORACLE WITH SEATING ARRANGEMENT (developed by this Institute) on one time license and royalty payment basis. The MRP of the product shall be fixed by the ICAR-CIFRI. Royalty of Rs. 500/unit of sale is fixed on the product.

The interested and willing firms who want to participate in the tender may submit the requisite mandatory documents like valid registration, trade license, Income tax returns, GST, PAN, TIN, relevant experience in manufacturing of fisheries/ aquaculture products with bid document form which can be downloaded from the institute website **www.cifri.res.in**.

### 7. Eligibility Criteria

The bidder(s) who will be empanelled should have extensive and proven mix of skill and expertise in the field of manufacture of fisheries and aquaculture products to be used in fish/animal related industry. The bidder should have previous experience of similar work. The bidder must meet/satisfy the following minimum criteria which should be reflected in the Bid

- 1. The Bidder should have prior experience in manufacturing detection kits.
- 2. The Organization should have at least Rs. 5, 00,000/- of annual turnover during 3 (Three) financial years.

3. The Bidder should not be Black Listed by the Government of India or any government agency. An Affidavit to that extent is to be submitted along with the Bid documents invariably.

## 8. Documentary evidence to be submitted to support eligibility

The bidder must submit all related documents including the following

- a) Valid Registration, Trade license, IT returns, GST, PAN, TIN and income tax clearance.
- b) Contract/work orders indicating details of assignment, client, clientele value of assignment date and year or award of at least three projects in Government/PSU / public limited organizations.
- c) Documentary evidence of annual turnover of minimum Rs. 10, 00,000/- during 3 (Three) financial years.
- d) An Affidavit with regard to non-Black Listing by the Government or any Government agency.

**Note:** The eligibility criteria (under clause 7) and documentary evidence to be submitted (under clause 8) may be relaxed in a case of a start up firm. ICAR-CIFRI will assess the eligibility of Start-up firms case to case basis and is the final authority in this regard.

- I. Tender Fee (vide para 5 above): Rs. 1,000/- (One thousand only) in the form of Demand Draft drawn in favour of ICAR Unit -CIFRI, payable at SBI, Barrackpore. The Tender cost is non-refundable.

  - IX. All payments of supply shall be made directly to the accounts of the firm through e-payment. Hence, Bank details like A/c no., name of Bank, name of branch, IFSC Code should compulsorily be provided.
  - X. All disputes including court proceedings shall be subject to the Kolkata Jurisdiction only.
  - XI. The Director, ICAR-CIFRI reserves the right to accept or reject any quotation without assigning any reason thereof.

#### 10. General Terms and Condition:

- 2. The firm should pay One-time license fee to the Institute.
